

# Polyclonal antibody against Mycoplasma pneumoniae

### **CATALOG NUMBER:** PAB0011

**IMMUNOGEN:** *Mycoplasma pneumoniae* recombinant antigens P1 and P30.

**SPECIFICITY:** Monospecific, reacts only with *Mycoplasma pneumoniae infection* epitopes. Non-reactive with normal human serum.

**PREPARATION:** Isolated from sera of rabbits immunized with highly pure (>98%) recombinant multi-epitope chimeric antigens for *Mycoplasma pneumoniae infection*. Anti-*Mycoplasma pneumoniae* specific antibody was purified by protein G affinity chromatography.

PURITY: >95% (SDS-PAGE)

PRESENTATION: dry powder

SOURCE: rabbit

## LOT SPECIFICATIONS:

1. RECONSTITUTION: with 0.080 ml of sterile doubledistilled water, a final concentration of 1.17 mg/ml will be obtained (A  $_{\rm 0.1~\%}$  = 1.4). The solubilization of the cake should be developed for 15 min to allow a homogeneous antibody solution, considering that part of the cake can be on the glass-walls of the container. Please keep in mind that the final volume of the reconstituted protein solution may differ from the reconstitution volume mentioned in the instructions due to the hygroscopic nature of trehalose. As the protein is reconstituted, the final volume may slightly increase to reach the specified amount mentioned in the certificate of analysis. Upon reconstitution, leave the solution at least 15 min homogenizing with a mild agitation at 4°C. void vigorous shaking that can cause foaming and protein denaturation. After those minutes, centrifuge the vial to ensure that all the product remains at the base and do not lose any of it on the walls. With this reconstitution, the antibody will be maintained at pH 7. It is recommended that the users carry out their absorbance determinations to avoid concentration variabilities due to the equipment used, mainly in reproducibility analysis.

## 2. TOTAL QUANTITY PER ALIQUOT: 0.1 mg

**3. STORAGE:** Antibody is shipped at room temperature. Upon arrival, it should be stored at 4° to -20°C in vertical position, avoiding all possible humidity and maintaining the vials dry. Once reconstituted, it should be aliquoted to avoid repeated freezing and thawing cycles and stored at -20°C to -80°C.

## **4. WESTERN BLOT:** suggested titer approx. 1:15,000.





Figure 1. Western blot analysis of the polyclonal Ab against the catalog numbers: RAG0053 (P1), RAG0051 (ChimMp) and RAG0041 (P30).

**Antibody titration assay.** A titration assay of the antibody was performed with a fixed concentration of the recombinant antigen.






A 4-parameter logistic regression (4PL) model was used to fit the sigmoidal standard curve.

The suggested titer for Ab PAB0011 in ELISA assay is between 1:3,200 (0.3656  $\mu g/ml)$  and 1:409,600 (0.0029  $\mu g/ml).$
